THE HISTORY OF MEDICINE IN GERMANY AND FRANCE IN THE FIRST HALF OF THE 20TH CENTURY HAS IDENTIFIED, IN BOTH COUNTRIES:

- 1 | An intense and constant growth in the use of cinematography for public health instruction. Dealing with topics such as sexual hygiene and infectious diseases to enlighten and to instruct the public, these films became more elaborate and complex in a filmic sense, developing from a pure documentary character to more differentiated, sophisticated and even avant-garde forms.
- 2 | Despite the increase of medical film production, central figures dominated the medical film production from the 1920s to the 1950s in both countries: Jean Benoit-Lévy (1888-1959) in France and Nicholas Kaufmann (1892-1970) and Curt Thomalla (1890-1939) in Germany. Further, these figures were all at the centre of intellectual networks.

This workshop aims to analyse developments of medical film history by comparing the oeuvre of Benoit-Lévy and Kaufmann/Thomalla and to address questions of bio-political discourses, political involvement of the directors, their choice of medical topics, their publications, their use of film developments, the modes of medical film production, as well as the projection of the films and their reception.

By discussing their work in a French-German comparative perspective, we aim to question dominant interpretations and frameworks as the individual/local versus national or the national versus the global. Additionally, this broader comparative perspective will provide new insights into mutual film influences: not only how one film inspired another but how networks of influence evolved over almost half a decade.
